On Thursday, April 14th 2016 at approximately 2253 hours, I responded in non emergency mode to 53 Ashford Way Griffin, GA 30224 (Ashford Place) in reference to Police Information. Upon arrival I made contact with Matthew Boynton.

Matthew stated that he was in the shower using his cell phone. His wife, Jessica Boynton walked into the bathroom and pulled the shower curtain back and took his cell phone. Matthew then got out of the shower and asked Jessica multiple times if he could have his cell phone back. Jessica stated that he could not have his cell phone back until he admitted that he is cheating on her. She then began to poke him in the chest with her finger telling him to admit that he is cheating.

Matthew also informed me about an incident that also occurred at Walmart on Thursday, April 14th 2016 at approximately 2320 hours. Matthew stated that he and Jessica was inside Walmart and they started discussing how the baby will get the formula he needs when they split up. They then walked out to the car and Jessica said she wasn't getting in the vehicle and she would find another ride home. She then walked back into Walmart. Matthew then contacted Lt. Keys and asked what he should do. Matthew then left Walmart and went back to his residence without Jessica because he could not get her in the car.
